The personnel so designated above will be eligible to wear the uniform of the prescribed post. They will not be eligible for higher pay and allowances other than what they would have received . They will be accommodated among the available sanctioned posts in the rank of regular CPOs and are also responsible to discharge their duties of the actual post . They will not have any claim of seniority in the designated category. The personnel who has been designated to the Grade SCPO will be promoted to the cadre of



SCPO as the case may be as and when their turn comes in the regular line of promotion unless they found ineligible and strictly on the basis of her position in the seniority list of regular CPOs and on the basis of the recommendations of DPB. This order will not alter the existing rules with regard to the D/Authority under KPDIP & A Rules & MDP.
