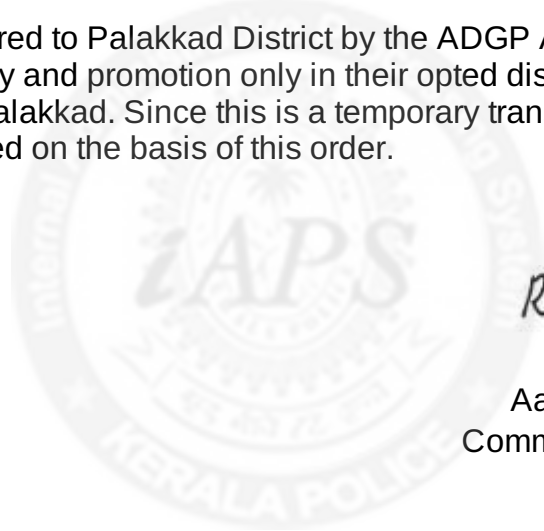

DC AR will passport the incumbent with direction to report before concerned SHOs and report compliance.

The above said Transfer is purely on temporary basis under extreme administrative exigency and in public interest. The temporarily transferred Police personnel to Thrissur district other than their opted district are not eligible for any seniority/promotion/etc in the temporarily posted Unit/District. When vacancies subsequently arise in the District upon their choice, transfers will be effected to such vacancies strictly according to seniority of the persons who have opted for Palakkad District. However, this shall not have any adverse bearing on the seniority of the temporarily transferred personnel, who shall be eligible to be transferred to their opted district, ie Palakkad as per arising of vacancies in Palakkad district.

They will be transferred to Palakkad District by the ADGP AP Battalion in due course. They can claim seniority and promotion only in their opted district with effect from the date of by transfer to KCP Palakkad. Since this is a temporary transfer, no further General Numbers shall be issued on the basis of this order.
