Dy. Commandant DHQ, Thrissur will relieve / Passport the Personnel accordingly with direction to report before the concerned SHOs. After implementation of this order he will report the exact vacancy position of the CPOs in AR for availing strength from KAP 2nd Battalion. The transferees will not be eligible for any joining time. The concerned officers will report the date of joining duty of each person to this office by return. In case anybody has not reported within the time limit it will be reported to the undersigned in Name Cover. Dy.Comdt, AR will ensure that the passport in respect of the persons, who are actually relieved, are issued to the officers concerned. In case of CPOs on deputation or working arrangement, their passport will be issued only after their physical reporting in the AR Camp for accepting the local transfer. They will be taken in the strength of Local Police only after their physical joining in the respective Police Station . Hence they may be directed to report as early as possible to accept the Local transfer on repatriation from Deputation / working arrangement. Hence in the case of Personnel attached on deputation / working arrangement in other special units. the concerned unit head will



relieve / passport the transferees forthwith with direction to report before the Dy. Comdt, AR, Thrissur for effecting the local transfer.
