The Names of employees who are due to retire from service during the month of 31st July 2021 to 31st December 2022 (18 months) are furnished below. They will retire from service with effect from the afternoon of the last day of the month in which they attain the age of superannuation, as noted against their names. They will not be retained in service beyond that date.

All officers are directed to verify the date of birth of all persons working under them with reference to their small service books etc. and corrections/omissions if any noted should be reported in time. If any officer is received on transfer from any other district or separate unit subsequently is found due for retirement on superannuation during 31st July 2021 to 31st December 2022 after the issue of this DO, their name, rank, date of birth, etc should be reported to this office by officers concerned under whom he/she is working without fail for verification and incorporation of their names.

All officers should ensure that no person is in service beyond their retirement dates and that no one is excluded from the list. If anybody happens to draw and receive pay and allowances after their retirement, the concerned Officers/ ISHOs will be held personally responsible for the lapses. A report should be submitted to this office immediately after the concerned is relieved of his duties on retirement.

The Officers concerned will direct the retiring personnel to submit their pension application through online in PRISM Software (Pensioner Information System) (Website - WWW.prism.kerala.gov.in) A copy of this order should be got noticed by the respective person under proper acknowledgment and they may be instructed to submit their pension documents as mentioned below to this office well in advance at least six months before their date of retirement. The retiring person will fill up pages (PRISM) of the pension book.

1. Pension Book ( PRISM) Application.
2. Identification particulars, Specimen Signature left-hand thumb and fingerprint duly attested by the ISHOs concerned.
3. Three copies of Joint photographs of the individual with their wife/husband, of these two photographs should be pasted in the pension book and three of them should be attested by the ISHOs concerned.
4. Nomination for lifetime arrears of pension (page 06) of Pension Book – (PRISM)

5. Declaration under Rule 117 A (Page 10 of Pension Book- (PRISM) Application  
Gazetted Officers should send their pension book and connected documents to this office  
for forwarding to PHQ, well in advance.

Liabilities if any outstanding to Govt. from the retiring officers should be assessed and reported to this office sufficiently early, to effect recovery in a lump from their last pay. The SHOs/Unit officers should assess and settle liabilities at least 15 days prior to the date of retirement of the individuals as required in PHQ Circular No: 39/12. On option, the subscriber can stop the subscription to the GPF account within one year before their retirement. As per GO(P) 255/90 Fin dated 28.04.90, the subscriber to FBS is given the option to remit the subscription in a lump for the last six months prior to retirement for the speedy settlement of the claim. The subscription to State Life Insurance can also be made like this, but the final settlement of this scheme will be after the retirement of the subscriber, for ensuring continued insurance coverage.

Concerned unit Heads/ISHOs should forward the following report to the District Police Office immediately after the date of retirement of employees concerned.

1. Liability / Non-liability report.
2. No, leave roll pending report.


If this list is found correct, a certificate to this effect that the date of birth of all the officers has been verified and there is no one to retire before 31.12.2022 except the persons showed below should be submitted within 7 days. If any error is noticed in the list after verification of SSBs /MH Sheet etc.that fact should be reported to this office forthwith.
